### Trump Suspends New H-1B Visas

USA President Donald Trump suspended H-1B, L and other impermanent work grants, which he said is planned for ensuring nearby specialists who are confronting joblessness because of the spread of coronavirus. The choice was impacted by the US tech industry, which said it would hurt advancement and defer the recuperation of the US economy. #### What is H-1B Visa?

### Trump Cites Unemployment Numbers:

For instance, Trump stated, among February and April of 2020, in excess of 17 million United States positions were lost in ventures in which bosses are looking to fill specialist positions attached to H-2B non-immigrant visas.

"During this equivalent period, in excess of 20 million United States labourers lost their positions in key ventures where businesses are at present mentioning H-1B and L labourers to fill positions," he said.

"The passage of extra labourers through the H-1B, H-2B, J, and L non-foreigner visa programs, along these lines, presents a noteworthy danger to business open doors for Americans influenced by the exceptional financial interruptions brought about by the COVID-19 episode," Trump said.

### Exemptions to the Order:

The new principle would apply just to the individuals who are outside the US, don't have a legitimate non-foreigner visa and an official travel report other than a visa to enter the nation.

As indicated by the declaration, it doesn't affect legal perpetual inhabitants of the United States and outside nationals who are life partners or offspring of an American resident.

Outside nationals trying to enter the US to give brief work or administrations basic to the food gracefully chain are additionally excluded from the most recent decree.

### Who all does it impact?

Since the boycott is taking effect right now, the handling of all new H-1B, H-2B, J, and L visa classes stand suspended. This implies the individuals who don't have a substantial non-foreigner visa as of June 23, and are outside of the US, won't be permitted to enter the nation until December 31. Laborers in fundamental administrations in the food area have been given some relief, and their entrance will be chosen by the consular official of migration administrations.

### How does it impact Indian IT companies?
